The Difficult Truth

Some vaccines are developed using aborted fetal tissue, and some even contain aborted fetal cell line remains in the final product.

This has been widespread since the 1960s, when Leonard Hayflick developed the first widely used aborted fetal cell line ([WI-38](#)) from the lungs of a little girl, and used to it grow viruses in her remains for use in vaccines.

The Body of Christ simply has not been adequately and accurately informed on this devastating fact.

Pro-life believers have been participating in the abortion industry, most unknowingly.

It is time to face that we have been taking part in unfruitful deeds of darkness, to repent, and to come out of sin.

This presentation is only a brief overview of the issues and discussions of vaccines that Christians must wrestle with.

God's Calling

Ephesians 5:6-17

“Let no one deceive you with empty words, for because of these things the wrath of God comes upon the sons of disobedience. Therefore do not become partners with them; for at one time you were darkness, but now you are light in the Lord. Walk as children of light (for the fruit of light is found in all that is good and right and true), and try to discern what is pleasing to the Lord. **Take no part in the unfruitful works of darkness, but instead expose them.** For it is shameful even to speak of the things that they do in secret. But when anything is exposed by the light, it becomes visible, for anything that becomes visible is light. Therefore it says,

“Awake, O sleeper, and arise from the dead,
and Christ will shine on you.”

Look carefully then how you walk, not as unwise but as wise, making the best use of the time, because the days are evil. Therefore do not be foolish, but understand what the will of the Lord is.”

Abortion and Vaccines

The “unfruitful work of darkness” of Abortion has been a part of the vaccine industry beginning the 1930s, when Albert Sabin began developing a polio vaccine.

Albert Sabin, 1936:

“A new approach was made by the use of 3- to 4-months-old human embryos, obtained aseptically by Cesarean section...The brain and cord, the lungs, kidneys, liver, and spleen were stored in the refrigerator, fragments of these tissues being taken for the preparation of media at 3-day intervals.”

The Cell Lines

Here we review the most commonly used cell lines in medicine and vaccines, and some of the products that used their tissue in development.

We begin with WI-38, the cell line for which we have the most information in the medical record.

WI-38

WI-38: Wistar Institute, Specimen No. 38,
32nd Abortion

- Abortion performed in Sweden and shipped to Leonard Hayflick, Wistar Institute, Philadelphia
- Lung tissue 3 months gestation female
- Used to culture RA273 for rubella and MMR vaccines
- Patent owned by the US Government

The Children Sacrificed

Ginger Taylor of No Deception:

“For years we have talked about the WI-38 cell line as if it rolled off an assembly line, and it is not the remains of an innocent little girl who was murdered. Referring to people by numbers is dehumanizing.

In our conversations about this child, her lungs, her cells, her DNA and her blood proteins, we felt more and more empty as we continued to refer to her, and what was stolen from her, by a number assigned to her by Leonard Hayflick, who contracted with Sven Guard to carry out her murder to obtain her lungs in Sweden in 1962 ...

So we named her Winnie.



Winifred Isaksson could be the name of an elegant Swedish woman in her late 50s, and it is the formal name that we have given to her so that she may be referred to with the dignity that is due every child of God.

Here we have given her a portrait to symbolize who she might be had she been left alone to grow into a school girl in Sweden.”

In the near 60 years since her death, Winnie's biological material has been injected into the majority of humans on earth.

Participation in the abortion industry, and the purchase and injection Winnie's cellular remains, including her blood proteins and DNA, are now legal requirements to receive a public or Christian school education in **five states**. California, New York, West Virginia, Mississippi, and Maine.

MRC5

MRC-5: Medical Research Council, Abortion No. 5

- Abortion performed in UK for “psychiatric reasons”
- Lung Tissue, 14 weeks gestation male
- Used in some Polio, DtaP, Hib, Rabies, Chickenpox, Hepatitis-A, Hepatitis-B, Zostavax for shingles vaccines

Mikey

We have named the British boy that was killed for his cells, marketed under the product name MRC-5, Michael Richard Christian.



Mikey was a child who was fearfully and wonderfully made, and whose life gave God joy. We honor him and those who suffered his fate.

WALVAX2

WALVAX2: Abortion in China, 9th Abortion

- 3 months gestation female
- Lung tissue
- Developed in 2015 specifically to replace depleting supply of WI-38 and MRC-5
- Developed in Wuhan, China

Little Dani

Lanie Danae contacted us about this cell line child. “Little Dani is the name I gave the baby girl WALVAX-2 was derived from. It means “God will judge.” Danielle Wong now has a name.



HEK-293

HEK-293: Human Embryonic Kidney, Specimen No. 293

- Abortions performed in Netherlands, researcher later claimed in Congressional testimony that he could not remember if the child was the product of an abortion or miscarriage, as both were used in the project. Total number of aborted children used is unknown.
- Kidney Tissue; Gestation age not recorded
- Used in drugs, Pulmozyme, Repro, Eloctate, rhFVI, Nuwiq & Ebola vaccine in development
- Used to map the Covid spike protein, thus used to develop ALL current Covid-19 vaccines. (Does not remain in the final injected vaccine solution) Used to test Moderna and Pfizer vaccines.

Helen

In 1973 Helen Emma Kristiansen was a child whose kidney cells were taken from her to develop the HEK 293 cell line, which was used to replicate the SARS-Cov-2 virus, map the spike protein, and test the Covid-19 vaccines.



PER C6

PER C6: Abortion in Netherlands, “mother wanted to get rid of the fetus, father unknown”

- Aborted at 18 weeks gestation in 1985
- Retinal tissue
- Designed specifically for the pharmaceutical industry; in Ebola, HIV, Malaria and TB vaccines in development
- Used in the production of Janssen / Johnson & Johnson Covid-19 vaccine (remains in final injected product)

Percy

In 1985 Percy Smit was being knit together in a mother's womb in the Netherlands, and should have opened his eyes to see God's creation. Instead his eyes were used to develop the PER C6 cell line, used in the Johnson & Johnson Covid Vaccine.



RA273

RA273: Rubella Virus used in Rubella and MMR vaccines

Rubella, A=Abortion, 27=27th aborted baby, 3=3rd Tissue where virus was isolated

- 6 weeks gestation; sex not recorded
- Isolated from kidney by Dr. Stanley Plotkin
- 40 more elective abortions for rubella virus isolation by T.H. Chang, (67 total) *
- 67 abortions to produce rubella virus, plus 32 abortions to produce the cell line for cultivation, means there was a total of at least 99 elective abortions to create the rubella vaccine alone.

Refraan Angelus

In 1965, Stanley Plotkin at the Winstar institute was searching for a sample of the Rubella virus by harvesting tissue from aborted children. His final product was RA 27/3. The name RA 27/3 refers to “Rubella Abortus”, 27th fetus, 3rd organ to be harvested (the kidney).



We have named this child Refraan Angelus, meaning Choir of Angels, in honor of the 27 babies whose organs were harvested in Plotkin's project.

Why do we buy these products?

The simple truth is, if the Church stopped buying products made from the bodies of aborted children, it would force an end to the use of fetal cell lines in medicine.

But we don't.

So the practice continues

The business is profitable, and continuing. In March [Judicial Watch](#) reported that a lawsuit in the US Federal Court confirmed that the US Department of Health and Human Services was illegally purchasing aborted fetal organs for research:

“Both the FDA and NIH purchased the organs from California-based Advanced Biosciences Resources (ABR) to create “humanized mice” for use in HIV research. ABR partners with Planned Parenthood and other abortion providers to dismember fetuses and sell their parts for research.

The decision notes that ABR:

sold second-trimester livers and thymi for hundreds of dollars apiece. The same for brains, eyes, and lungs. After tacking on fees for services like shipping and cleaning, ABR could collect over \$2,000 on a single fetus it purchased from Planned Parenthood for \$60. The federal government participated in this potentially illicit trade for years.”

Vaccines Are Liability-Free Products

In 1986, Congress passed the **NATIONAL CHILDHOOD VACCINE INJURY ACT**, severely limiting liability for vaccine manufacturers, and ultimately removing the 7th Amendment rights of Americans to sue the industry when vaccines caused harm. This dramatically increased the profitability of vaccines.

The Act set up the **National Vaccine Injury Compensation Program** to compensate those cases, and families were required to apply to the “VICP” before suing vaccine makers. Even though the program has paid out more than \$4 billion in claims, most cases of vaccine injury are never filed, as few families are informed of the program, and only a fraction of filed cases are paid. Most vaccine injuries are simply denied and ignored. Thus, the cost of vaccine injury falls on the states, local municipalities and the families themselves.

When you are injured by a vaccine, **YOU ARE ON YOUR OWN.**

Justice Department Announces Largest Health Care Fraud Settlement in Its History
Pfizer to Pay \$2.3 Billion for Fraudulent Marketing

WASHINGTON – American pharmaceutical giant Pfizer Inc. and its subsidiary Pharmacia & Upjohn Company Inc. (hereinafter together "Pfizer") have agreed to pay \$2.3 billion, the largest health care fraud settlement in the history of the Department of Justice, to resolve criminal and civil liability arising from the illegal promotion of certain pharmaceutical products, the Justice Department announced today.

Pharmacia & Upjohn Company has agreed to plead guilty to a felony violation of the Food, Drug and Cosmetic Act for misbranding Bextra with the intent to defraud or mislead. Bextra is an anti-inflammatory drug that Pfizer pulled from the

U.S. Pharmaceutical Company Merck Sharp & Dohme Sentenced in Connection with Unlawful Promotion of Vioxx
Judge Imposes Nearly \$322 Million Fine For Illegal Marketing

American pharmaceutical company Merck, Sharp & Dohme was sentenced by U.S. District Court Judge Patti B. Saris in Boston to pay a criminal fine in the amount of \$321,636,000 in connection with its guilty plea related to its promotion and marketing of the painkiller Vioxx (rofecoxib), the Justice Department announced today. In December 2011, Merck pleaded guilty to violating the Food, Drug and Cosmetic Act (FDCA) for introducing a misbranded drug, Vioxx, into interstate commerce.

Merck Vaccine Lawsuits

Although childhood vaccine liability is extremely limited, Merck still manages to have a slate of lawsuits underway for their vaccines, via their own company whistle blowers for **falsifying vaccine efficacy to the FDA**, the elderly for risks due to the **Shingles** vaccine, and even minors for Gardasil.

Merck accused of stonewalling in mumps vaccine antitrust lawsuit

(Reuters) - Two former Merck & Co Inc scientists accusing the drugmaker of falsifying tests of its exclusive mumps vaccine said in a court filing on Monday that Merck is refusing to respond to questions about the efficacy of the vaccine.

Attorneys at Constantine Cannon, who represent the scientists, asked U.S. Magistrate Judge Lynne Sitarski of the Eastern District of Pennsylvania to compel Merck to respond to their discovery request, which asks the company to give the

Merck's **Gardasil** vaccine is the first company to be sued for a childhood vaccine injury since the passage of the 1986 National Childhood Vaccine Injury act. The law allows such suits if fraud is proven in a court of law, and Merck's open fraud in bringing this vaccine to market was so blatant that judges are now allowing a vaccine maker to be sued for injuries after 35 years.


